SPECIAL NOTICE!!

-The New York City Code requires that no equipment or apparatus can be connected unless it conforms to its electrical code. The hotel will supply an electrician to correct any minor infractions at stated labor costs.

WIRING REGULATIONS BASED ON THE ELECTRICAL CODE OF THE CITY OF NEW YORK

-All electrical apparatus and splices must be installed in a metal enclosure to prevent emissions of sparks.

-All metal raceways, metal lighting fixtures, metal housings of electrically powered equipment shall be grounded.

-All extension cables shall be 3 wire SJ cord or other approved type or not more than 25 ft. long. One of the wires with green colored insulation is to be used as ground. The cable must be large enough for the load and have a grounded male plug.

-Flexible cords and cables less than No. 12 gauge wire shall not be permitted.

-The use of lamp cord, cube taps or similar devices are not permitted.
